The election of representatives to SpareBank 1 Nord-Norge's Supervisory Board will be held

Thursdag 13 February 2020 at 09 a.m in SpareBank1 Nord-Norges main office, on the fouth floor. The address is Storgata 65, Tromsø.

The Supervisory Board is the bank's highest governing authority. They meet once a year. The Supervisory Board consists of 40 members and 20 substitute members. 16 members and 6 substitute members in the Supervisory Board represent the holders of equity certificates.

To be elected are 16 members and 6 substitute members. The election period is 4 years. Enclosed you will find the list of the proposed candidates.

Those entitled to vote are the holders of equity certificates registered in the Norwegian Registry of Securities (Verdipapirsentralen) at the time of the meeting. Each equity certificate carries one vote.

Owners of equity certificates who wish to attend and vote must complete and return the enclosed *Attendance Form*. Owners who wish to be represented by proxy are requested to complete and return the enclosed *Form of Proxy*. Both forms must be registered as received by the Bank administration by **Monday 10 February 2020 at 3 p.m.** 

No fee/travel allowance is payable for participation at the election meeting.
