

DNO in Norway





- 1971 Det Norske Oljeselskap AS (DNO) established
- 1984 First license in Norway
- 2003 Sold majority of Norwegian assets to Lundin (Alvheim area)
- 2007 Contributed its Norwegian assets to Det Norske Oljeselskap ASA, the international assets remained with DNO
- 2017 Re-enters Norway through acquisition of Origo Exploration



A challengers spirit

- MENA presence since 1998 through acquisition of Yemen assets from Norsk Hydro
- Entered the Kurdistan Region of Iraq in 2004, operating world-class Tawke oil field
- MOU with Iran for the more than two billion bbls-in-place Changuleh field

Growth through the drill bit


- Since 1998 operated more than 150 exploration, appraisal and production wells
- More than 112,000 bopd of operated production from Tawke in 2016
- Upside in the Peshkabir discovery on the Tawke licence and more than two billion bbls-in-place on the Erbil license
- 530mboe 2P+2C reserves at end 2016

Facilitated successes

Norway based

- Low lifting cost of USD 2.40 per barrel of oil equivalent at Tawke in 2016
- Competitive advantage in challenging oil price environment
- Flexible capex with limited commitments
- Strong balance sheet
- NORSOK standards important basis for DNO's operations internationally
- Development based on Norwegian heritage and mind-set
- OSE listed with market capitalization of approximately USD 1.0 billion as of June 2017
- Significant Norwegian institutional and retail shareholder base of more than 17,000 shareholders (16,600 Norwegian)

Significant changes since Origo's start-up in 2014




Good timing to position companies for future growth

New entrants to the NCS






DNO uniquely positioned for the NCS

- Substantial international reserve and production base through world class Tawke and upside through Peshkabir and Benenan (Erbil license)
- Active through the drill bit currently four rigs in operation
- Significant operating experience full scale E&P organization of 800 employees
- Strong balance sheet and returned to profitability in Q1 2017
- Headquartered in Oslo, listed on the Oslo Børs and 16,600 (44%) Norwegian shareholders
- Returns to Norway as a significant European independent E&P

Norway: Origo a solid platform for DNO growth

- Prequalified as operator in 2016 in Norway; licensee in UK
- Office, IT and extensive G&G databases established
- Reviewed > 300 farm-in deals (all recorded in the database)
- Executed eight farm-ins, five NCS and three UKCS
- Awarded three licenses in APA 2015.
- Submitted nine applications in APA 2016, but had to withdraw the applications
- Operational status
 - 3D seismic acquisition West of Shetland (2015)
 - Participated in eight wells and four side-tracks
 - Four discoveries 50% technical success rate
 - Commerciality of discoveries being reviewed

Transition to DNO Norge already underway

- DNO to acquire 100% of the shares in Origo Exploration Holding subject to customary approvals
- Origo Exploration will be renamed DNO Norge AS
- Management, staff and office in Stavanger will be retained
- Existing business processes, including Business Management System, to be integrated with DNO's systems
- Growing the business in Norway is a priority for DNO



Ambition to be a significant company on the NCS

- Aim to establish DNO Norge AS as a significant company on the NCS
- Long-term industrial perspective
- Active explorer through APA, numbered rounds and farm-ins, including Barents Sea
- Acquire discoveries, production and development assets in order to create a full life cycle business
- Long-term desire to be operator also for developments and production



A Truly Diversified E&P Company

- 36 nationalities in our workforce of more than 800, of which 10% are women
- DNO proud of its nationalization track record:
 - Sindy rig fully staffed by Kurds ("Team Ferrari")
 - o Several managerial positions by locals, e.g. Tawke field manager and Somaliland deputy GM
 - Oman branch staffed by 53% by Omanis
 - Yemen operations run by 95% locals at the peak in 2011
 - o Iran team includes 3 fulltime Iranian professionals
 - 51 staff at Oslo corporate office with 12 different nationalities







DNO Operational Capabilities

Full scale organization with significant activity

- Operate all current activity: Full scale technical, operational and administrative organization of more than 800 employees
- >100 wells operated since 2000; 3-4 rigs in operation in 2017, of which one offshore
- 200,000 boepd processing facilities
- Extensive expertise in carbonate reservoirs

Professional HSE, governance models and practice

- Strong HSE commitment
- Industry governance and operating protocols, including NORSOK
- Internal audit, compliance and risk management







Kurdistan: Tawke is a World Class Field

- At 111,000 bpd, DNO's Tawke production is double that of all other IOCs in Kurdistan combined
- Fast track development, production just 2 years after start of exploration
- Passed milestone of 200 MMbbl cumulative production in May 2017
- More than 550,000 bbl storage capacity, 200,000 bpd processing capacity, 2 pipelines
- Good safety and security track record, active social responsibility efforts, high local content
- 2017 Kurdistan plan: Fast track development of Pishkabir field following 2016 discovery, Bennenan heavy oil production, active reservoir management at Tawke







Oman: DNO, the Only Offshore Operator

- DNO is operator of Block 8 offshore license in Oman
- Long history and proven track record of subsurface knowledge and operations in Straight of Hormoz
- Production of 5,300 boepd in 2016, split evenly between oil and gas
- In midst of a drilling campaign to double production in 2017
- Completed a complex P&A and sidetrack drilling, below budget while using NORSOK standard
